Tuesday, the CRPD will be voted on.

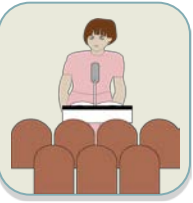
A small and **LOUD** opposition is using misinformation to take the votes we have. Senators opposed think the disability community will NOT win.
