# **General - Day 1**



Acting chairperson Jennifer Allen welcomed everyone to the 2<sup>nd</sup> meeting of the Network. Members introduced themselves and reviewed the draft meeting Ground Rules. Correction was made to #8 ("or" to "of") and approved with correction. Kecia W/motion & Kyle M./second. Members also reviewed the agenda for the day and agreed. Members decided to review April meeting notes in November (along with July meeting notes). Not all members had a chance to look at the notes posted online. Jennifer suggested if hard copies are needed, members should ask supporting organizations to print. Members also suggested they put their SSAN flash drives in a box as they arrive in the morning so Joan Burg (BRC) can collect them and add (download) information files to each one and return to members before meeting begins.

# Leadership Coaching Presentation

Brian Marsh (Leadership Coach) introduced coaching and how it can assist anyone with personal goals and plans by supporting the person to focus and find their own answers and success.



Kecia W. helped illustrate coaching with a role play of a session where she acted out: "How can I be a strong advocate if I'm I am not empowered?" and stated:

- "I make my own decisions."
- "If I'm compliant I lose power and control."
- "Don't let other people tell you what to think."

Kecia described her plan and actions to achieve greater empowerment. She agreed to report her outcomes at the November meeting.

#### **Network Outcomes**

The Network is established to be region centered and ongoing. The Network builds partnerships with new groups, represents many different people and creates plans with real life outcomes. Network members gain expertise and share what they learn with future members

who come after them. Regions and organizations are provided support to be successful.

## Emerging issues around the state

State Legislation/Budget-

- \$200 million reduction in DDS budget and may be more if November ballot initiative on tax increases does not pass.
- A 3.6% IHHS reduction remains.
- A move to managed care for more Californians on MediCal.
- Employment First Policy is moving forward in state legislature.

## **Network Branding**



Leslie Levine (Design and Tech Specialist) reviewed the ideas of Network branding and tag lines, using member suggestions from the April meeting.

The logo/tag line ideas need to be posted on Google Group by August 9<sup>th</sup> so decisions can be made and

posted by the end of August. Leslie will post reminders on Google.

#### **Discussion: Important Issues to Members**

Voting – Members shared information regarding problems with votingand access at polls. Several members had assistedcommunity members in the past and have been involvedin voter education activities.

They also suggested resources (Disability Rights California- DRC and California Foundation of Independent Living Centers-CFILC) for voting rights and access.

#### Assignment for July 26

Members were asked to think about suggestions for a Network mission statement and return the next day with what they would prefer to guide the Network into the future.

## General – Day 2

Acting chairperson Jennifer Allen welcomed everyone to the 2<sup>nd</sup> day of the July Network meeting. Members introduced themselves and shared reports on assignments. Members also reviewed agenda for Day 2 meeting and agreed.

## **Committee Business - Election of Officers**

#### Candidates for Chairperson

Members gave short speeches (Jennifer, Jimmy, Trena, Daniel, Austin). Written votes were cast and **Austin** was elected as Chairperson.

#### Candidates for Vice Chairperson

Members gave short speeches (Jimmy, Sigrid, Kyle, Jennifer, and Trena). Written votes were cast and **Trena** was elected as Vice Chairperson.

#### **Committee Business - Mission Statement**

Members selected several mission statements to determine what they want to include in a final Network mission statement. Results were:

- 16 votes Build a bridge between the Network and community to promote leadership, disability rights and a united voice.
- 13 votes Promote leadership that strengthens advocacy and builds bridges among communities, statewide and national policies.
- 9 votes Connect with others across the state in different communities to create a united voice.
- 5 votes Listen to people, be a channel of information and lead by example.

7 votes All of the above

**Austin** agreed to study the choices and return in November with suggestions for a final mission statement to be approved by Network membership.

# **Committee Business - Operating Rules**

Network members reviewed sample Network Operating Rules and decided to establish a two (2) year term for Chair and Vice-Chair and create a Secretary position. Job description for the Secretary position needs to be developed.

#### **Member Reports**

Members shared information about their advocacy mission statements and activities in their communities, regions or sponsoring organizations.

Reports were videotaped for a video report at the end of the year (September).

#### **Information Sharing & Gathering**



Members exchanged information and resources:

- Accessibility is very important.
- Information on services needs to get to high school students.
- Some regional centers may not always support requests but it's important to fight for what you need.
- Network should move towards contacting the CA governor.
- Do we know our neighbors? Very important for emergency preparedness.
- Regional Centers need competition.
- Think about underserved groups such as military veterans.
